Noel moved and Hinrichs seconded a motion to forgo readings 1 and 2 and approve the updated policy 905.08 School Closings and Cancellations as provided by NASB. Motion carried 5-0. Swartzendruber moved and Johnson seconded a motion to approve the Covid-19 Resolution as presented by KSB Law and agreement to pay classified staff during the school closing for work completed and agreement to return to work. Motion carried 5-0. At 9:30pm Johnson moved and Hinrichs seconded a motion to enter into executive session for the protection of public interest to discuss the Addendum to Negotiated Agreement. Motion carried 5-0. At 9:55pm the executive session ended. Hinrichs moved and Johnson seconded a motion to approve the Addendum to Negotiated Agreement as amended. Motion carried 5-0. At 10pm Swartzendruber moved and Noel seconded a motion to adjourn. Motion carried5-0. The next regular scheduled meeting will be Monday, April 13, 2020 at 7:30pm in the Superintendent's office.
